**Entries**

Entries are limited. There will be 2 trials each day.

**Pre-Entries:**

Sheep: \$40

Ducks: \$25

**Day of Show (if available):**

Sheep: \$50

Ducks: \$35

All entries must be made on an official ASCA entry forms.

Entries close on August 15th or when the trial fills, whichever comes first.

Day of Show entries (if available) will be taken from 7:30 to 7:55 am.

Additional entries will be made from a waiting list established in order of receipt. Additions will be made prior to the start of the trial and are at the discretion of BASC.

There will be NO refunds. Exceptions will be made for injuries or emergencies on a case by case basis.

Substitutions after Entries close will be allowed with a dog owned by the same person making the original entry with no additional fee. Other substitutions will be allowed with a \$10 fee. No selling of runs. All transaction are handled by Course Director.

You will be notified by e-mail of entry receipt before the trial. If trial is full, you will be notified immediately. Please write or type your information clearly on your entry.

Bitches in season will run in order.

Run order will be pre-drawn and posted the day of the trial.

Move ups are permitted between trials on that day provided that a move-up form is completed and given to the course director. Forms will be provided the day of show.

Dogs that attack or maul any person, dog, livestock will be disqualified and subject to ASCA rules and regulations.

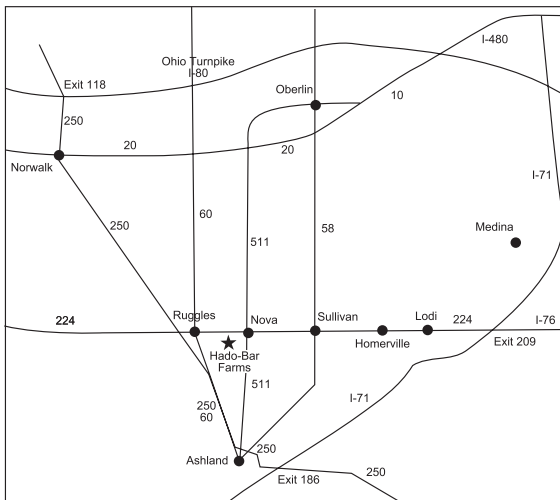
Replacement costs are: \$20.00 per duck, \$200 per sheep unless posted otherwise at time of trial.

Run limits and judging assignments are subject to change.

**NOTICE TO EXHIBITORS:** This is an ASCA event and will be judged and run by the stockdog trial rules of the Australian Shepherd Club of America. Dogs will be leashed Except when trialing and must be brought into the trial arena on leash. Entries will be Accepted on a first-come basis and must be made on the ASCA entry form. Run order will be determined by the course director and posted prior to the beginning of the trial. No electrical and/or mechanical training devices will be permitted on the trial grounds. Any questions or problems should be brought to the attention of the course director. The stockdog trial committee is authorized to request that any dog which, in the committee's opinion, represents a hazard to persons, dogs, or property be removed from the premises. Children must be kept under the direct supervision of an adult at all times. No entry fee will be refunded if the show can not open or be completed due to riots, civil disturbances, acts of God, public emergencies or other events beyond the control of BASC. Trialing can be inherently dangerous. Therefore, individuals are responsible for any damage done to or by himself/herself, his/her family, his/her visitors, and his/her critters. **AGREEMENT**

- 1.1 As used here, "ASCA" means the Australian Shepherd Club of America®, its affiliate clubs and each of their members, officers, directors, employees, show chairs, show committees, and agents.
- 1.2 Exhibitor/owner agrees to abide by the rules and regulations of ASCA® and any other rules and regulations appearing in the premium for this event.
- 1.3 Exhibitor/owner certifies that the entered dog is not a hazard to persons, dogs, or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.
- 1.4 Exhibitor/owner acknowledges all hazards presented by the event and the event premises, including, but not limited to: the condition of the floors, stairways, halls, lighting, security measures (or lack thereof), electrical appliances, fittings, show rings, parking areas, and the presence of unfamiliar animals and people. Exhibitor and owner assume the risk of any harm arising from these.
- 1.5 Exhibitor/owner releases ASCA®, the ASCA® affiliate/licensee club hosting the event (including its officers, directors, members, and event organizing committee), and all site owner(s) harmless from all present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, the event, or event premises. Without limiting the generality of the foregoing hold harmless provisions, exhibitor/owner hereby specifically assume sole responsibility for, and agree to indemnify and save aforementioned parties harmless from, any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damages because of bodily injuries, including death, at any time in consequence of my (our) participation in this event; howsoever such injury, or death, may be caused, and whether or not the same may have been caused, or may have been alleged to have been caused, by negligence of the aforementioned parties or any of their employees or agents, or any other persons.
