STOCK & VALUE: Shetland, Shetland X, or Dorper X sheep (\$125 replacement value). Rouen ducks (\$30 replacement value).

Good fences make good facilities. Handlers will be assessed \$15/hr. for labor to repair damage to fences or gates caused by rough handling of stock.

- Owners or their agents are solely responsible for the presence of their dog(s) for judging. Judges need not wait for dogs.
- Exhibitors are expected to clean up after themselves & their dogs.
- Bitches in season may be moved to the end of the class at the judge's discretion. Please notify the Trial Secretary if your bitch is in season.
- Please bring your own chairs.
- Electronic, telephone, & unsigned entries cannot be accepted. Payment must be made at time of entry.
- Exhibitors must be present at Handler Briefings.
- Spectators are encouraged (and it's **FREE!**)
