AGREEMENT

Herding is inherently a dangerous activity. Dogs, livestock, and people may be injured during herding. Therefore, in consideration of my working livestock with my dog, I (we) agree to the following:

1. Livestock/facility Owner has right to refuse to let me or my dog work stock.
2. Livestock/facility Owner will be held harmless from any claim, loss or injury which may be alleged to have been caused by this dog while in or about the event premises.
3. I (we) personally assume all responsibility and liability for any claim against this dog, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury, or damage to this dog.
4. I (we) will pay for any injuries or replacement value in the event of serious injury to the livestock caused by my (our) dog. Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend, and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting there from, sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such injuries, death, or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons.

Clinician Molly Wisecarver to the Helena area August 11 and 12, 2017

This clinic is intended to meet each handler/dog team where they are in their training—from beginners to more advanced students. Facilities include two round pens (one free standing), two arenas, and numerous sorting pens and alleyways as well as a 10-acre field. Sheep (both hair and wool) and ducks are available. With plenty of options for working spaces this clinic should propel dogs and their handlers to new levels of achievement!

Friday start time: 10:00 AM – **Saturday** start time 8:00 AM
(Dogs should be at least 4 months old and up to date on vaccinations to participate in the clinic.)

Molly started herding in CA in 1989 after purchasing her first Aussie. She was immediately hooked (!) and soon stopped barrel racing to commit all her spare time to herding. Experience in equine competition and knowledge of livestock served her well in learning to train stock dogs.

Purchasing her first Border Collie in 1991, Molly began competing in United States order Collie Handler's Association (USBCHA) field competitions. She added American Kennel Club (AKC) arena trials in 2002, after the family moved to Arizona. Molly continues to trial in American Herding Breeding Association (AHBA), Australian Shepherd Club of America (ASCA), AKC, and USBCHA events with both her own and client dogs.

Molly has worked with many breeds, including Border Collies, Australian Shepherds, Belgian Malinois, Belgian Tervuren, Belgian Sheep Dogs, Australian Cattle Dogs, Cardigan Welch Corgis, Bearded Collies, Shelties, Berger Picards, Rottweilers and German Shepherds. She adjusts her training methods differently, depending on both the breed and the temperament and drive of individual dogs.
