TRIAL INFORMATION: Draw for run order will be after trial registration closes. Bitches in heat will run in order of draw, but must be crated and exercised away from the competition. All breeds recognized by ASCA as herding breeds are eligible to enter the trial. Owners of dogs will be responsible for all injuries to livestock; replacement cost will be determined at fair market value. Handlers meeting at 8:30, trial starts at 9:00AM. Day of entries taken 8:00-8:30 AM. If any changes or cancellations participants will be notified by email.

Maximum of 10 runs of sheep-advanced/open (3-5 head), 4 started runs will be on GOATS (3-5 head) 6 runs of geese (5 head), 4 runs of cattle (3-5 head) per judge, AM and PM arena trials.
