All entries **must be postmarked and may not be postmarked before February 1, 2020. NO EXCEPTIONS. Entries accepted in postmarked order. Run order will be drawn before the trial. A waiting list will be established when or if trial fills. **Bitches in heat will run last.

AM trial handlers meeting 7:30 AM – PM trial handlers meeting 12:00 PM or 10 minutes after AM trial concludes
Trials will start immediately after meetings

No set out dog will be used for these trials

Entry & tracking forms available online at www.ASCA.org Dogs not registered with ASCA **must** have tracking number on entry to receive a title with ASCA. If writing "pending" on entry, tracking number must be received by trial date or you will be required to re-apply at the trial.

Awards: BELT BUCKLE for high combined score (AM & PM). Placement ribbons 1st-4th will be awarded. High in trial rosettes for Open & Advanced will be offered. Other awards may also be presented. Ties will be broken by time. In the event of a score & time tie, trials will be broken by sort & chute work.

Directions:

From Reno: 395 South to Hwy 88 (first signal as you come into Minden). Go right for about 5 miles. Watch for trial signs on right.

From Sacramento: Left side of Hwy 88 about two miles North of the California/Nevada state line.

From So. California: 395 North to first signal at South end of Gardnerville (Pinenut/Riverview). Go left past 7-11 (Riverview). Stay to the right and continue through two stop signs. At third stop sign go right and continue to Highway 88. Go left on 88 and travel about 1.25 miles. Watch for trial signs on right.
